The Judges

From the Forum:

Jim Tracy: Thursday 6-14 Early temps low 60's & light rain PM temps low 70's overcast

Scenario 1 didn't quite work out because of winds crossing a hot blind. The judges saw the test dog and scrapped it for the backup test that they already had in their pockets. Nothing quite like a crew of experienced judges.





Scenario 2 Goose hunt where Mallards, (I mean big mallards) invaded the goose dekes.

Bird #1 left pop n throw nice & square. About 60 yards medium cover.

Bird #2 Right pop n throw off tree line angling slightly in down the tree line, I think about 60 yards.

Bird #3 Center live flier left to right i'm guessing 85 yards.

Blind - Line between falls 2 & 3.

This looked like an easy test, much easier than Scenario 1 by far but





The cover was very decieving and many dogs had to be handled to the go bird live flier because of the canopy of ivy that covered the fall area. Quite a few dogs had to be handled on more than one mark, usually the right bird was more difficult. The blind had inherent suction in both directions from the old falls as regardless of the wind you would have to push thru the scent cones and the cone of the flier was big, especially for some of the later dogs.

Birds were huge nice mallards.

Help was incredible and organization superior.

Dogs were challenged but not beyond Senior dog standards.

Judges were relaxed and had a calming effect on handlers, (most of 'em.)





Larry Housman:

Jim gave a pretty good rendition of the test. 4 dogs were dropped from group A, and one from group B, with one scratch from group B. 46 dogs to upland and trail tomorrow. This was the first test I've run where the money bird was the go bird. That flyer was just a real tough bird to pick up if you didn't mark it dead on, since there was so much scent around, and with the cover so thick, the dogs weren't seeing it until they were basically standing on it. Very, very tough mark.

Gunners were great, only one no-bird all day, but fortunately it came just after I induced my dog to break so I got a re-run and Nils bailed me out. Awards for stupidest handler and luckiest handler are now set in stone, and on the same series no less!

Jim Tracy:

Thursday 6-15 65 degrees Overcast Winds light & variable

Quarter, Steady to Flush Started with Flight B, dog # 26.

Enter perpendicular to dirt road into light to medium cover with gunners on each side judges ahead and on the left. Quarter hunting for about 60 yards to one of two box launchers with fully mayure Chukar. Bird goes up & hopefully dog goes down. Make retrieve, (or not if you get a flier) and turn 90 degrees parallel to road and hunt slight side hill with heavy cover on the left that was heavily scented.



Nice test with judges emphasizing the hunting (read quartering) and working the cover and staying within gun range. Most dogs doing well with high throws from the launchers and not too many fly aways. Gunners are challenged because flush is coming about 10 to 15 yards ahead of the dog.



Right turn exit after about 100 yard quartering after the flush and lead back on when you hit the dirt road.

Maggie got a low flier, (she sat) that came right back over her head and she tried to pluck it from the air then spun 180 degrees and whistle sat with her eyes looking like this Shocked

Very Nice test!

On to the trail with the running flight reversed again, dog # 1 will be first.



Jim Tracy

Friday 6-15 PM Report 70 degrees overcast virtually no wind

Trail was run starting with Flight A dog # 1.

Enter holding blind, remove lead. Very close dry shot from judges on other side of holding blind. Walk past judges to a ribbon and pile of feathers to initiate trail down a tree line to the left. Many reports of an "S" shaped trail along the tree line with a right 90 degree turn after about 60 yards. Follow turn looping back like a small r towards the holding blind for maybe 25 yards and pick up the duck on the edge of light to medium cover on the edge of a plowed field. Not hard, but certainly not a gimme.

All dogs that entered the trail carried.



Larry Housman:

Lost three dogs on the upland.

Jim Tracy:

Saturday 6-16 AM 68 Degrees PM 80 Degrees No wind

Bird # 1 Far left 85 yds hand thrown into a pocket between bushes with big angle entry.





Bird # 2 Center 75 yds behind and between cove with lilly pads to the left of the line and water bushes to the right. Money Bird. Bird # 3 Go bird about 35 yds hand thrown left to right into a pocket of water.





Blind between bird 2 & 3. More tight to # 3 because it was on a small brush point on the same shoreline.

Honor on the right side and well away from the working Dog!

Quite a few handles and in about equal number on birds 1 & 2. Memory bird was a little more difficult because of handler nerves but the dogs that took an initail line couldn't really get into too much trouble. Bird 2 could be troublesome but was aided by a BIG TALL winger throw and Mondo splash.

GREAT Test and a challenge to anybodys nerves.

WAY to GO Judges and Handlers.

Water test picture:



Really great test. very challenging, but also very open so you could see your dog to handle if you needed to. I disagree with Jim that the middle bird was the money bird - I thought it was the left hand bird, as many, many dogs beached early and had to be handled to the mark. Plus there was no splash.

In the picture, the right hand mark looks like it lands in heavy cover. It actually landed in one of several small guts that ran out from the right, so if the dog broke through the cover it was out in the open.

Unfortunately I let Nils down and we didn't pass. We had tons of points to give away on the water, and I screwed up and gave them all away and one more. We were fine on the marks - I took a handle on the left mark that I probably didn't need, but knew I could afford. The problem was the blind. In retrospect I should have just run the blind fat to the left and avoided the suction on the right, but since the test co-chair, Frank Plewa, has raised me from a pup to always challenge the blind, I did it again. The little guy was probably never more than 3' off dead center the whole way out, right until he was no more than 8-10' away from the blind, and then I lost him to the right and we were toast. The good news is that he's a dog, has no idea any ribbons were involved, and is happy he picked up all the birds. Me too!



Journey to the GMHR

Well, I guess Tucker is an example of 'never give up'. At a year old he just wasn't working out to be what I thought I wanted in a dog and seriously considered sending him down the road. He loved his birds and retrieving was an OK game, but he just didn't have the sparkle that you see when you know you've got a good one. He earned his started title in 4 straight and his working retriever title in 4/5, but still just wasn't quite alive.

One morning while I was getting dressed I dropped my underwear and before I could bend over he snatched them up and delivered to hand. This apparently left a permanent mark because with out fail, every morning he hears the shower shut off and runs to the bedroom, fetches my 'skivies' off the bed and waits with his tail wagging so hard it's a wonder its doesn't break. This is one of those things that you just shouldn't tell other people, but I feel that it just goes to show what a wonderful attitude he has and his desire to please me.

Tuck earned his MHR at 26 months old and although he really should have had his 'G' before now, just after his 4th Birthday, a little hiccup came last summer to our household. IT'S ALL ABOUT THE DOGS

Over the last several years, I've had the opportunity to hunt both upland and waterfowl in Montana. Once you've experienced it, just hearing the name "Montana" will conjure up brilliant memories, make your heart start to beat a little faster and force you to start planning that next trip. An abundance of waterfowl and a large number of species of upland game are only the beginning. The country itself is spectacular, from wide-open plains to majestic mountains, from sweeping agricultural land to rivers that race and tumble from the mountains down through the canyons below and it's a state that's rich in history and heritage. The sunrises are awe-inspiring and the sunsets are simply gorgeous. And throughout this great state are good, solid, friendly people...and it seems like most of them are just as involved in outdoor sports as we are.





My wife's and my first visit to Montana was 5 years ago. Our very good friends, Paul and his wife Sandy, found some beautiful land in the southwestern part of the state and had begun to design and develop what has become an absolutely incredible ranch and home for them. It also now boasts some fantastic waterfowling (thanks to their work on habitat restoration), and is a perfect jumping-off spot for places like Judith Basin and its amazing upland shooting opportunities. That first trip we made was without a dog. So was the second...and the third. And then, finally, into our lives came Sadie...our now 3-year old female black English Lab.



Sadie was a gift from my in-laws, who are friends with the breeder in San Diego County (California). Originally, Sadie was not to have been ours. She had been spoken for, as had all the pups in the litter, but my mother-in-law, in her great wisdom, stayed in close touch with the breeder and was Johnny-on-the-spot when that little female "fell out of escrow." A phone call from my in-laws was all it took...or perhaps that phone call coupled with my wife having a dream that night about owning a dog named Sadie! Although we had decided to get a new pup, my wife wanted one she could pick up...I'm the one who wanted the black Lab. But, hey...at home Sadie believes she's a lap dog and she acts like one, so I guess sometimes things just work out right. The only thing is, Sadie is now 72 pounds so any lifting has to be done by "guess who?!"

Paul and Sandy have had black Labs for years, and hunting with Paul over his dog has always been an exciting experience for me. He and Sandy are avid outdoorspeople and are two of the most environmentally and ecologically responsible people I know. Paul's an excellent shot and safe hunter. He's a dear friend. And he taught me about Labs.

Sadie and I have had the extraordinary good fortune of hunting five species of ducks plus Canada geese, Hungarian partridge, sharptail grouse, snipe, pheasants and blue grouse for the last two seasons in Montana and I'll always remember Sadie's first Montana hunts. They were certainly a test of her training, and the experience she gained was invaluable.



On one hunt, we were after snipe in some marshy bottom land along the Big Hole River, and Sadie didn't know a snipe from a parakeet. Sadie was about 15 months old at the time and Paul's Jessie was about 19 or 20 months old. The first snipe that flushed with that distinctive raspy, squawking call got Sadie's full attention and thank goodness I hit it. Sadie was steady on the flush and the shot, and took a fast, hard line to her mark when I released her. She didn't seem very pleased with the taste, or maybe the smell, but she held it all the way to deliver to hand. I couldn't have been more relieved that her training was apparently paying off, and I couldn't have been prouder of her.

We've also hunted Huns, blue grouse, ducks and geese...and Sadie has had her taste of all of them except for that elusive blue grouse. On our first day of high country hunting for blues, we heard a few and saw one but didn't have an opportunity to shoot. Sadie, on the other hand, thought the smells and sounds in those high forests was like heaven. She quartered beautifully as we wandered through the woods and responded to every command, but I think she really best enjoyed learning about forests and snow!

The successes and fun we've enjoyed on Montana waterfowl have been amazing. Sadie's first ever retrieve on Canada geese was on a trip that included my in-laws. My father-in-law has been hunting all of his life, and over the years he and I have experienced many wonderful hunts together, so sharing a blind with him on this particular morning was a special treat. We'd been in the blind for a while, and as the sun began to creep a bit higher in the sky, Sadie spotted the geese coming in...and I got a double (yes, I got very lucky on that pair!). The first of the two was across a fairly fast-running irrigation ditch and out in the pond about 30 or 35 yards away, and the second (which she didn't see fall) finally tumbled into a stubblefield about 50 or 60 yards out. Sadie, who had had some lessons on "blind manners" and a couple of nice duck retrieves before the geese came in, was on top of that first goose in a flash. But I could practically hear her asking, "Hey, Dad...now whadda I do with this thing? It's huge!" She swam to one side and tried to grab it by the neck...she knew that was wrong. Then she swam to the other side and tried to grab it by a wing...she really knew that was wrong. Back around to the other side, she grabbed it exactly like she should, made the swim back out of the pond, across the irrigation ditch and delivered that Canada to hand. She thought she was done, but of course we had to go after the second bird...as I said, a blind retrieve for her at about 60 or 70 yards. With Paul, plus a friend of his, my father-in-law and our guide looking on from the two blinds (no pressure!), I gave Sadie her line and off she went. Being young and comparatively inexperienced, she of course started hunting short of the bird...but a whistle "sit" followed with a "back" or two along with a couple of "overs" and she winded that bird. Her pick up and retrieve from that point on were flawless, as was her delivery to hand...but I know those eyes of hers, and they were saying something that shouldn't be repeated in polite company! Those two Canadas were not just Sadie's first, they were my first, too...and they really were big guys! At that time, Sadie was only about 55 or 60 pounds and was used to nothing larger than a mallard, so her reaction to having to pick up those two Canadas back-to-back was pretty clear! It did not, however, dampen her enthusiasm. If anything, it helped to increase her drive and desire.



Subsequently, Sadie and I have hunted Montana waterfowl with Paul and his Jessie in weather ranging from a balmy 40 or 45 degrees under clear skies to a somewhat brisk 15 or 20 degrees with wind, snow and sleet. Last season, we added several days of upland hunting for sharptail grouse, Huns and pheasants in Judith Basin that included an amazing contrast in weather. One day, it would be brisk and breezy...the next, we'd wake up to howling wind and driving snow...the next, we might have rain, sleet and then even a little sunshine just to confuse things. Sadie, even though she's a "sort of Southern California" dog, has been virtually unaffected by the Montana weather. It's remarkable how tough and resilient Labs are. It's also amazing that at the end of the day, Sadie and Jessie still have the energy to occasionally pop up from in front of the fire and chase each other around the living room!

Whether you have the good fortune of having friends to stay with, or you book a trip with one of the many outstanding outfitters up there, a Montana trip really should be in your future. The bird hunting is amazing, the country is truly beautiful and the memories of your experiences will last a lifetime.

Besides our Montana hunts, my wife and Sadie and I also continue to spend time with Paul, Sandy and Jessie hunting quail in Baja California (Mexico). The dogs work well together and still love to play like a couple of maniacs when they're not hunting. They've learned about honoring each other's marks (don't worry, Paul...I won't tell the story about the "shared" bird on their first quail hunting trip together!) and have become a great team in the field and in the blind. They're smart. They're tough. They're alert and full of drive. They're always ready to please. They're simply a delight to be with. And I can't imagine not having Sadie at my side, at home or in the field.





I guess when you think about it, regardless of how much any of us enjoys hunting, it doesn't matter if you're in Mexico or Montana, California or Connecticut, Michigan or Mississippi, or anywhere in between...it really is all about the dogs!

Justin loves to train, run tests and especially hunt – both waterfowl and upland. He has shown his versatility by earning retrieving titles (MHR & HRCH), upland titles (UH & MH) and our own top AWSC retrieving/flushing title (WDS).

AWS Biography



Justin came into my life as an eight week old puppy. We had raised American Water Spaniels since 1980, breeding several litters over the years but this guy was offered to me by my good friends Linda Hattrem and Pam Boyer. It was impossible to turn them down. Right from the start I knew that this dog had talent. It became apparent that my limited time and experience was not going to allow him fulfill his potential. Justin earned his started titles with my training and handling and then I decided to send him to a trainer in North Carolina. That was a wise decision --- Justin started to come into his own.

Justin earned his HR with his trainer handling him. Then I brought him home and we earned his WR going four for four at Skunk River and Okoboji. We ran spaniel tests the remainder of the summer earning five master passes. Last spring we finished his HRCH – and just three days later, my husband died suddenly at the age of 62. I was devastated. The dogs became a comfort and a burden at the same time. At the urging of my close friend, ten days later, with only two days of training, I ran Justin in the local spaniel tests in an attempt to earn his final pass for his MH. He pulled it off in style. It was a bitter sweet moment – I went from elation to tears of sadness in the blink of an eye.

I didn't have the heart to train much the rest of the summer but Justin still earned three passes toward his MHR. I went to Iowa in September hoping that he could pull off one more pass but the lack of training had caught up with us. This winter, back in the Carolinas we earned his UH. This spring we struggled in NAHRA tests – we just couldn't put it together. We finally got that final pass one year to the day since he had earned his HRCH and the last day to qualify for the RAW.

On the advice of many of you on this list, I decided to go to the RAW. I was looking forward to running. Much to my dismay we ran into major problems......

On the official day of training, he picked up two cheat grass seeds in his left ear. We were doing some land marks and a blind -- I was going to quarter him out and he started shaking his head. I looked into his left ear, saw the seed but couldn't get it out. The vet had to put him under to reach the seeds that were way down in his ear. They look different on the plant from foxtail but work just the same. The little barbs allowing it to only move in one direction.

Things went from bad to worse as he started shaking his head. We managed to pick up the marks in a very ugly fashion – it was hard for him to concentrate with the problems he was having. He didn't want to pick up the birds and once he did, he would set them down to shake his head. I could tell he was miserable. I decided to try to run

the blind. He gave me what he could but I picked him up. He was in such pain, I couldn't stand to watch him. He couldn't run more than a few feet without shaking his head.

He didn't have a chance to pass or fail on his own (he is capable of either) because, as it turned out, he picked up two more of those nasty seeds in his left ear and one in this right ear. Again, we had to put him under to get them out. His left ear was a mess. It took him three days to feel good and longer for the ear to heal. I cannot tell you how disappointed I was that he was out because of circumstances out of our control. Thanks to the many folks who showed concern for Justin. You were great support. Special thanks to Patsy Hove and Brenda Hershberger.

But, in spite of all of that, I stayed on to the end to learn what I could, get better acquainted with more great NAHRA people and cheer on the participants. Oh yes, and eat! Congratulations to everybody - I especially want to congratulate my fellow Four Points club members Dan Tongen and Abby, Troy Tilleraas and Ky and Dan Hershberger and Kenya.

Thanks to the committee (headed by Frank and Scott), workers and judges for all their hard work. It was a great event and we plan to run next year! We hope to see you all in Minnesota.

We will be hitting the ponds, fields and forests this fall as we try to get as much hunting in as possible but in the mean time we have more training to do tests to tackle.

May Board of Directors Meeting

In May the NAHRA Board of Directors approved several important changes.

At the May meeting, the NAHRA Board approved a new addition to titles for qualifiers at the Richard A. Wolters / North American Hunting Retriever Association Invitational field tests. Each time a dog qualifies at an Invitational, a roman numeral after the dog's top NAHRA title will be increased to indicate the number of Invitational qualifications the dog has had. For example, a dog finishing his first Invitational might be MHR-I Marsh Mutt and a five time Invitational veteran might be GMHR-V Mallard Muncher.

The Board considers this a well earned additional recognition for these dogs.

Congratulations to the 2007 Invitational qualifiers - get ready for 2008 & -II (or more).

The policy for training on the field test grounds has been changed to 48 hours. The complete policy is posted in the NAHRA Info block and has been changed in the ONLINE rules.

The 2008 RAW/NAHRA Invitational Field Test will be hosted by the Four Points RC near Minneapolis 13-15 June 2008. (See p.36 below.)

We also had an entertaining time auctioning of articles donated by club members, Sportman's Warehouse, and MSGDA to raise money to keep those live fliers coming up from the lower 48 . Out of the 20 Started dogs that entered 5 qualified and no dogs from the Intermediate stake qualified.



The Senior stake had 8 dogs signed up with one scratch. The judges were Mr. John Johnson and Mr. Greg Monroe. The test started with the land series then moved down to the water to finish up. Out of the 7 dogs running 2 qualified.
