How do you describe your best friend and companion?

We got Toby from Trish Jagoda of Silverbrook Kennels in Virginia; he was all of 5 pounds when we picked him up. There was so much snow that year, I didn't think he would know how to pee on anything but snow. Toby and I spent every minute together that winter, I took him to work with me, to the bank, the post office and even took him upland hunting. He didn't actually hunt but he loved dragging around those pheasants by the tail. That Winter I was introduced to NAHRA by my buddy Bob Sipila who has a 1000pt dog named Scooter. Toby was only 4 months old when he received his first NAHRA started pass, what a thrill! That same day we also

failed our first test. I think we got the most out of the failure that weekend. It was a great learning experience. Tom Moore judged that test and Tom has haunted us all the way up the ladder. Tom is a great judge and we love running under him, (thanks Tom for always challenging us). From there he achieved his MHR Title at 14 Months and his GMHR at 19 Months. Now at 4 years 9 months of age he passed his 50<sup>th</sup> senior test at Old Dominion Retriever Club in Virginia to give him his 1000<sup>th</sup> point. That last 20 points wasn't easy though. A truck hit Toby only 3 weeks before that test. Doctors didn't think he would be recovered so quick as to even be just running around. When I took Toby in 2 weeks after the accident they gave him the ok to go. See what happens when you buy a knot heat from Virginia they're too stubborn to even think they're injured. We ran that weekend under a close watch, but I think he knew what was going on and just ran his heart out. It was a great thrill and accomplishment for the both of us.

In addition to running field test and hunting all over the country, Toby is a great dog at home. All the kids in the neighborhood come over to see him. They think if they keep throwing the ball long enough they will wear him out. I

think their parents send them over for Toby to wear them out. When company comes over he will do everything in his power to get someone to throw for him, it's an obsession. Other times he can be found sleeping in my chair with the cat. Overall he is everything we could of asked for in a dog, loyalty, love and Respect.

Toby, Christine and I would like to thank Bob Sipila and Scooter for getting us to buy our first lab and spending hours throwing birds for us, Trish Jagoda of Silverbrook Kennels for putting up with us and showing us the way. Trish went the extra mile for a guy she did not know and was a royal pain in her ass, we have become great friends, Dino and Dawn DiPaola for all the fun and crazy times on the road and keeping my wife company and sane, all the people at HHHRA and Navasink who threw birds for us especially Kim Schiller my training buddy, Scott Unkel and his family and last but not least Frank and Valerie Plewa who gave me a reason to keep training even when I knew they would come up with something I did not train for. Thanks to all the people who made this possible.

handlers understand what judges look for, while others will want clinics to help train new judges and keep existing judges “on the same page.”

The power point materials prepared by the Hosford committee in '06 and Brad's own materials will be discussed to help people excerpt manageable sets of their own materials for various purposes.

## 2008 Invitational Judge Randy Carlson

It was 1970 and the weekly edition of American Sportsman was on Saturday afternoon (at that time, the only outdoors television show). As a passionate outdoorsman at 12 years old, I never missed an opportunity to learn more about hunting and fishing. The episode was Phil Harris, Bing Crosby, and Richard Wolters with a black lab, in a duck blind somewhere. One of them knocked down a bird and Richard sent his dog for the retrieve, and then proceeded to direct him to the bird with a series of whistle and arm commands, which left me astounded. That show was truly a defining moment for me, as I made a promise to myself that someday I would train a lab to do the same.

I was fortunate enough to meet and befriend Richard Wolters when I lived in New York. NAHRA was a young organization then and I quickly became

involved. Every Friday evening it was pack up the truck and head off with our friends to run the next test. When we moved to Nebraska we met the great folks at HPHRA in Cheyenne, WY, made new friends, and continued to be active in NAHRA. In April 2007 we moved back to central Pennsylvania to be closer to family.

I am an ardent bird hunter and fly fisher, and couldn't imagine a household without at least one lab to liven things up. Cathy and I have trained our dogs one at a time, reading the books, talking to friends, and joined local retriever clubs and NAHRA, and learned through trial and error. I love to chase both upland birds and waterfowl and have lived in Vermont and New York where I became active in NAHRA in 1986, and lived in Nebraska for six years where the definition of incredible waterfowling

may have been written. Hunting, fishing, water, and retrievers have always been an integral part of my life. NAHRA Hunt Tests were the perfect year-round extension of the sport.

I have trained by own retrievers and progressed them through each level and have run in and helped to coordinate Invitationals in the past. I enjoy judging at tests and watching other dogs as much as my own, and am always amazed at the athletic ability of our dogs. Judging an Invitational is a very important responsibility and not one that I take lightly. It is recognized how much time and effort each of us puts into training, culminating with qualifying to run in a NAHRA Invitational. My co-judges and I will strive to give you a fair, challenging, and fun test at the 2008 NAHRA Invitational.



## 2008 Invitational Judge Larry Dusanek

I was raised on a farm in eastern Iowa. We always had a herding dog on the farm. Dad trained all of our dogs. I got my first dog when I was eight. It was a rat terrier and came from a neighbor. She became my first hunting dog. The only magazine, other than farming types, we received was Sports Afield. I always looked at the ad section hoping to find my first real hunting dog. When I was twelve, I saw an ad for a lab pup in Omaha, Nebraska. I used some of the money from my 4-H calf and purchased my first Lab. I had no idea what I was doing when it came to training. I took a lot of lessons from dad and ended up with a decent hunting dog, but, by no means the kinds of dogs we see today. I've been learning ever since and hope I never feel that I have it all.

I have had the privilege of owning a number of great hunting dogs. Most of my early years were spent working with dogs as a meat hunter. In 1970, we moved to Mason City, and our family became acquainted with a gentleman who ran field trials. At the time, my brother-in-law was living with us, and he really wanted to get more involved with the dogs. We both starting learning and training more than hunting. That led to

participating in some club trials and a few derbies. This was my first association with a professional trainer, and it proved to be more of a learning experience than all the books.

Over the years, I've had many opportunities to become acquainted with several other very knowledgeable individuals. A few years later, we moved to Chicago where work started to interfere with my hunting passion. We became dog "poor" for about six years. Since moving back to Iowa in 1993, we got back into hunting and dogs. We started running some AKC events and then, by chance, when looking for a pup, was introduced to NAHRA by Keith Stroyan. It didn't take long for us to understand the difference between the two groups. Since we joined NAHRA, we have had a limited relationship with the other organizations. We always look forward to attending NAHRA tests because of the folks who will be there and the friendly atmosphere that is always present. I believe NAHRA has the best program and people.

I've been a hunter all my life. Growing up, we had an extended family in our home that included a great grandfather

and two great uncles. Between them, my father and my grandfather, I can't remember a time when I was not hunting. I shot my first rabbit when I was six and will never forget my first experience with a shotgun. Since retiring three years ago, I hunt as much as possible. I made my first trip to Canada duck and goose hunting this past fall and hope to make many more. I still have some dreams of going to the Dakotas for grouse and to the south for quail.

I really enjoy running dogs and have been planning on running RAW for the past two years. My female has not cooperated the past two years, but this was to be the year that she would not be in season. However, when I was asked to judge RAW, my plans changed again. I feel this is the biggest honor one can receive from this organization. I am looking forward to working with the other judges in setting up fair and interesting tests. The grounds are magnificent and should make for great testing scenarios. I know we will all do our best to make this one of the most enjoyable and challenging testing experiences.

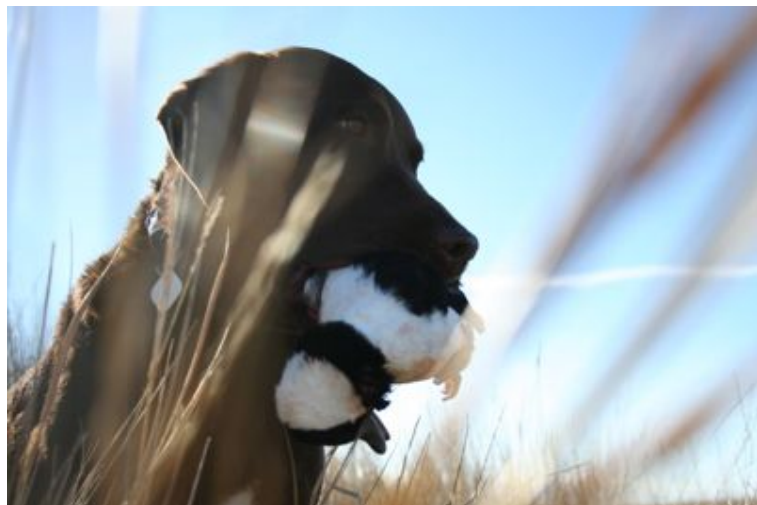

# You're going to do what with that horse!?

“You’re going to do what with that horse!?” My mom exclaimed when we brought our 9 week old Chesapeake Bay Retriever, Pocket, home in Nov of 2005. “We might hunt ducks with her,” Dustin and I replied.

The reason for the confusion - we’d never duck hunted before in all our years in Northwestern Ontario. However after moving to Calgary to go to school and then deciding to make Okotoks, AB our home we needed some hobbies. First on the list was getting a dog. After tons of research and finally picking a breed and breeder we then picked up Pocket. When speaking to the breeder, companion/family pet was the main objective with the hunting a possibility. So we brought Pocket along as a pet with basic obedience and some knowledge of what’s expected in the blind. We also decided to get a second CBR and brought home Dozer in Aug of ’06.

Well after a few times out in ’06 we were bit by the hunting bug early on! Pocket did very well that first season as we all limped along in learning the ropes. This spring we decided we couldn’t make it the whole summer till duck hunting and decided to try our hand at hunt tests to help us train the dogs, get them more experience and just for the fun of it. This past testing season of NAHRA was invaluable for all of us and we would not be having the season we’re having right now without it! We were humbled by the amazing dog work that we saw and how much we had to learn, but great club members, training days, judges and a great program have helped us to that next level- and although the work is far from done, we now know where we need to go and what it will take to get there. Pocket titled in Started and Dozer got a great jump start for his first hunting season.

Here's a recap of our 2nd Alberta waterfowl season:

Opening Day, Sept 8th. We were up bright and early as I don't think any of us slept and we were raring to go. So we load the dogs up, check all the gear and head off to a river hoping the scouting we'd done was going to pay off. Boy did it ever! First light and the birds were flying through the spread and Dustin knocked down a teal. We sent Pocket for the first bird and Dozer watched with anticipation for his chance. Well, then nothing really flew. So I grabbed Pocket and we head out down the river to flush and maybe bag a few. Ya not a good choice for me, but Dustin was dropping birds left, right and center for Dozer! He even got his first taste of a cripple and chased it down with enthusiasm and style and proudly pranced back to Dustin delivering his prize. I knocked down one and when we got back to the boys I was given a smug look by Pocket that stated she was not impressed with being stuck with me! I ended up bagging a few more before we called it a day with 11 ducks in the bag, teal and some pintails.

Our season was then put on pause for wedding festivities and a honeymoon but the day after we were back it was on again!

The beginning of Oct treated us very well with awesome weather and lots of ducks! We brought out 3 other buddies from home and hooked them with the bug too! Dozer came with us for a few more hunts but was tied out and only sent on really easy swim retrieves as he blew his CCL some time ago and was awaiting surgery. Training sure paid off and thank goodness we're preparing for WR. With 4 gunners on a regular basis there were multiple doubles and quite a few blinds that last year would have probably been retrieved by two legs with dog in tow.

This yr has been a much dryer and quieter season! A few highlights of October was an

amazing trail by Pocket on a wounded teal I winged that landed in the hay field behind us about 100yds away. The teal was retrieved about 300yds away and blew one buddy away as he had pretty much given up hope and thought there was no way Pocket could find it!

It was hilarious as this bird ran all over the country and then circled back and tried to head to the water and exposed itself in the short grass with Pocket hot on it's tail - it zigged and zagged and she was right behind with her head down when suddenly she snorts, peeked up and couldn't believe she was almost on it, then she pounced and brought me back my very much alive bird!

Pocket also chased a swimming teal down that swam out of sluicing range; another hunting buddy thought it was a goner, but Pocket swam out, tracked it down, tired it out and then dove under after it. It's a great feeling when that natural drive comes out and the dog shows you what she's made of. She made some wicked marks, chased a ton of cripples (can you say clay shooting before the season next year) and last light retrieves that made us all proud.

We took my brother out with us one night and that was just awesome to be in the blind with him and it was great to see him get his first bird.

November was actually pretty slow around here as it was unseasonably warm. We chased some locals and had a few good shoots but were also busy chasing deer and didn't tally too many until the end of the month. We also took Pocket out upland hunting and this dog sure has a nose! She made some nice flushes but there was some bi-ped shooting error and at times a young excited dog thought she knew better and could bag her own - note to self to train on steady to flush!

December is here now and wahoo it's cold! Not a lot of open water so when we find some it's on! The ducks are flying well, decoying great and the big mallards are down! We've gone out the past few weekends and although it's cold we're

nailing the ducks and Pocket is still as willing as ever to get in the water and bring them home! She's covered in ice by the time we leave but still sad to go and tries to hang back and hopes some more come up the river. Both times out we've had multiple gunners and with the birds coming in we've had to send her on some pretty hard blinds. Not to let us down though Pocket is handling amazingly and picking up the blinds very quickly and

efficiently! I think she's finally putting the training and hunting together and that is one special feeling!

We've had such a blast hunting waterfowl and made some awesome memories. I don't think we could be happier right now (unless Dozer could have joined us in the blind more often) and can't wait until next season. One thing is for sure, there isn't a 'maybe' in our vocabulary anymore!

## **Bob Riggs**

Indianola, IA

I have been employed by the Principal Financial Group in Des Moines Iowa for 12 years spending the first eight as an IT developer and the last four as an IT Project Manager. I grew up in southern Iowa at a time when Iowa was the pheasant capitol of the US. Needless to say I spent much of my youth chasing ringnecks around the Iowa landscape as well as other game that southern Iowa has to offer such as quail, turkey, deer and waterfowl.

Growing up we hunted with labs, but with little to no training there main purpose was to hunt the cover that me and my hunting partners either couldn't or didn't want to venture in to. After graduating from the University of Northern Iowa I acquired my very first lab and my first training book 'Game Dog'. We had some success and both learned a lot in his first year but a career change and more time in college left him not nearly as good as he could of been, but a solid hunting partner none the less. After settling in on a career and a marriage, my wife and I bought an acreage thirty miles south of Des Moines. Shortly after, I was on the lookout for another lab. After finding a litter, the breeder mentioned that he was associated with NAHRA and recommended that I see what it had to offer. That spring I traveled to Diagonal Iowa to watch a NAHRA test and was hooked. I met some nice folks there that gave me some encouragement and talked me into giving NAHRA a try.

I ran my first NAHRA test in the spring of 2001 and since then have run test all throughout the Midwest. In the early years of my experience with NAHRA there were very few tests in our Region so I also got involved with AKC, titling two dogs in AKC hunt tests. As family commitments grew and so did NAHRA activity in the Midwest Region I had to make a choice on a single venue. It was a simple choice for me to choose NAHRA, although I consider any organization that allows you the opportunity to sharpen the skills of your retriever well worthwhile. I currently have three labs that have run or are currently running NAHRA hunt tests and that spend many days with me in the fields and marshes during the fall.

I began judging in 2004 and have found that to be a very rewarding experience, as well as helping me tremendously with my handling and training skills. I have judged NAHRA events from Minot North Dakota to Pennsylvania and have really enjoyed those experiences with the dogs as well as the handlers. I am the current president of the Midwest Retriever club and have been since 2005.

I truly believe that the NAHRA program prepares a dog for the field in a manner far superior to any other. The members of NAHRA that I have had a chance to meet from across the country have truly represented the NAHRA ideals and all have a common thread of being sportsman and conservationist.

One of the things that was taught to me growing up was to always leave something better than you found it. I believe that the MW Region and NAHRA is growing stronger every year and that there is still tremendous potential to keep growing. I would like to help NAHRA realize that potential and hopefully leave it better than I found it.

### **1) What are the current strengths of the Region and how will you build on these?**

I believe the current strength of the MW Region is it's members. We have had tremendous growth over the last several years due the hard work and dedication of the members. I think one of the growing pains that our region has experienced is that we have not taken full advantage of pooling ideas and resources. I believe that the region would be stronger if the members from all clubs within the region worked together on a much more regular basis.

### **2) Which of the Regional Director duties will you emphasize?**

I think one of the things that must be emphasized is marketing and development. It seems that NAHRA has always been a well kept secret. One of the things that I believe in very much is that as an organization you must always be working to grow bigger and better. ### **3) What are the things you will work to improve in the Region?**

I will work to improve the communication and partnership between the different clubs within the region in hopes of leveraging what all of the clubs have to offer.

### **4) What can the Region do to help build the overall NAHRA program and how will you lead this effort?**

By making ourselves stronger as a region we will make NAHRA stronger as an organization. As a region we have the opportunity and responsibility to make sure our voices are heard at the national level. I will work to encourage and establish an open line of communication from the club level to the national level and with the other regions.

### **5) NAHRA H.Q. could use electronic modernization: an eOffice with online payment, eEntries, etc. How can the Region help with the initial set-up investment?**

I have a difficult time talking about an investment into any initiative before fully understanding what the issues and obstacles are. I think where all of the regions could help is in determining what the pain points of the current process are and help identify potential solutions to those issues. I would expect for all of the regions to have input and work with the Board to build a road map to a more modern office. I believe that there are some things we could do in the short term to move to a more modern state but I don't know that NAHRA is in a place to do anything on a grand scale at this point.

*NOTE: I disagree with Bob. Rosemary and I spend countless hours keeping NAHRA information up-to-date. Payments on line would be a boon. An eEntry service from NAHRA HQ could have many benefits for clubs and bring in those entry fees to the organization rather than giving them away with the ads they generate. We need modern database management Clubs in our region should contribute. KDS.*
