President's Bark

As I write this, there are still persistent splinters and various flotsam and jetsam embedded and cemented to me. Yes, it's blind building time again. Up until about a month ago, it looked like it was going to be an easy year of repairing and simply rebushing most of our blinds. But along came Ernesto and delivered us 12 inches of rain. Those 12 inches raised the water level so high it loosened our blind foundations and the wind did the rest. The added bonus of high water is all the displaced snakes.

All year long I plot and engineer my blinds and bounce ideas off the old timers in the area. Most of my ideas get a chuckle and I fall back to the old ways. I swear if I ever hit the lottery I'm going to have steel pilings put in and hopefully see the last of washing poles into the sand and mud. After the blinds are built I become addicted to the weather channel, hurricane season is not over by a long shot and we watch the storm tracks, like my labs watch me at the kitchen sink not only for our homes sake but for those most sacred retreats to the "blind."

The hours on the pattern field pay off as that pintail sails down out to the edge of the marsh while your dogs attention is solidly fixed on that bird splashing in the blocks. That big lean forward as the last of the birds hit the water and not that tell-tale splash as you clicked off the safety like last season. They get better every year until we are like one together in the field. Enjoy every moment, and forgive them when they mess up, after all even we miss sometimes. They are a short time here and a long time gone, make the most of it.

I hope you all have a great season afield with lots of the best kind of fellowship with your friends and loyal four legged companions. I am confident that your training efforts will increase your hunting pleasure as well as helping to preserve our resource. Perhaps you can make a difference in both NAHRA's and our birds' future and by introducing a fellow hunter to the program. Be careful out there and for you guys and gals in the Midwest go easy on them till I get there in early November

There's only been one human "girl" for me, my wife of 40+ years, Carol. But I have been blessed to have a string of Labragirls share my life. Some were truly good retrievers, but all were good companions. We loved each other.

Corkie, my first Labrador, had dwarfism and didn't go far in the retriever world, but she slept at my feet while I worked and knowing her kept me in touch with the medical research that I reported on in NAHRA News and Retriever Field Trial News. It's still on my website (just "Google" me.)

Roxie, Corkie's replacement, was a sweetheart whose specialty was eating junk food in front of the TV with my daughter. Roxie taught me humility by setting the record for the most NAHRA Senior tests failed by any dog. She really didn't like tests and after training hard all week before one would give up at the strangest times.

Once we drove all the way to Michigan and Roxie hung in all day – just barely. Carol kept saying, go out now Roxie, it's 500 miles drive home... Well, the last series was combined, marks, a blind, then a trail. She was worried, but did a good job on the marks and blind. As we left that line and started back up a hill there was a trail – usually Roxie's favorite test. Well, Roxie's attitude was – OH NO, ANOTHER TEST. I CAN'T DO THAT. She started up the hill and went around a little corner out of my sight, but in full view of the judges and gallery at the top of the hill.

There she sat in her worry until the judges said, "Please pick up your dog." She was hiding from me...

My wife lectured me all the way home late into the night about how she could have done that at 8 am. We forgave her, of course, and she was the only dog to dance at my daughter's wedding.

Vico was a daughter of Richard Wolter's "Taaahhh" and a Southland kennels dog. What a character. She liked to "talk" to us at breakfast, though she must have been frustrated that we had so much trouble learning her language. I can still see her laying on the dog sofa with her head hanging off. Vico was named by one of my students, it's a Spanish nickname for Victoria.

Vico was a VERY high-powered dog, not afraid of anything! She had a lot to teach me after Roxie... Quite a hard dog to handle, but her last year running NAHRA with me she lined every blind... so we learned to communicate.

Libby, Libby, Libby was next to come to our house. We got her as an older dog and she tested positive as a carrier of dwarfism when the test first came out. She also taught me that the saying, 'you can't teach old dogs new tricks,' has a

lot of truth to it. She did do a good job as loving house pet for our neighbors.

Kate was next a daughter of the great Cedar Valley's Hi-Bird Turk and Tim Post's Casha, daughter of Blackgold's Candlewood Kate. Kate was a very special dog. It's hard to describe. While she had some training flaws, caused in part by my slow learning of how to train, she was VERY focused on her handler. Too much so, I guess she wanted to be in charge. She went to live with a friend in North Dakota when he moved just after she finished MHR. I hunted with her every Fall – wow what a marsh dog.

I had planned to breed Vico to Candlewood's Super Tanker, at the time an up and coming youngster. Vico turned out to have bad hips and Joyce Williams, Tank's owner, turned me on to a promising litter. When I picked Nell, the owner changed his mind and took my pick, so she was my "second choice." Nell turned out to be my soulmate, the greatest canine love of my life. When I dedicated my latest book to the great loves of my life, Carol, Nell, and Infinitesimal Calculus, Carol remarked, "At least I was ahead of the dog."

Nellie should have been named joie de vivre – she loved life like no other being I have known. Marking machine and upland hunter of boundless energy. Nell found birds other dogs couldn't. I remember one time being very surprised when she picked up one in training after 6 other dogs had been unsuccessfully through the same area. Her last hunt at a shooting preserve on a cold December day after she had lost an eye to melanoma and had advanced lung cancer was amazing. There were lots of birds in good cover and she hunted like a puppy – drunk with bird scent and excitement.

Nell had litters by Harley, Abe, and Bubba that produced my girls, Tess, Daisy, and Dinah. She did mark as well as her mom and was simply amazing on a big banana mark where she literally stepped on the bird.

She would hunt gophers in our yard, mice, bunnies, ... 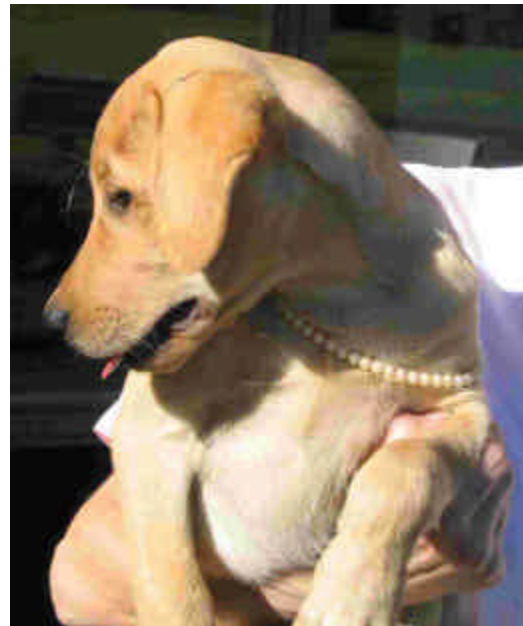

From the Northeast

We have just completed the Northeast test schedule and I am pleased to say that our entries went up approximately 20% over 2005. Not a bad way to go into the hunting seasons! Since my last report, 8 clubs have held 9 test events. Several included the pilot Hunter Stake and from the early reports, the testing level was well received.

June marked the first licensed field test for our newest club, the Nutmeg Retriever Association based in Connecticut. While the remnants of a hurricane dumped on them all weekend, they persevered and all seemed to have a good time. It is my understanding that all the tests were "water" series!

For the second consecutive year, Horseshoe Hunting Retriever Club (Ontario) held a licensed event in July. From the report back, the event was very successful and a good time for all. Why not, they had Canadian beer!

In August, Southwestern Pennsylvania Hunting Retriever Club and Silverton Sporting Ranch both hosted double-staked events that were small, but successful. Southwestern Pennsylvania Hunting Retriever Club is going on twenty years of hosting their August test while the Silverton test marked the return of NAHRA to Maine. A big "atta boy" goes out to the Navesink River HRC for their solid support of the latter test event.

Also in August, Leatherstocking Hunting Retriever Association and Northern Piedmont Retriever Club hosted small events geared primarily for the local membership but as always, open to anyone interested. The latter test featured a double pilot Hunter field test. While the entries were only 11 dogs in each stake, the judges got their first look at the Hunter Level here in the Northeast.

Actually, Four Points Retriever Club (Minnesota) held the first event earlier in August. While that entry was a little lower, it will provide much needed information for the final evaluation of this level. While some are skeptical of this initiative, many of the folks I have spoken with see potential for it to become a permanent part of the program. I encourage everyone to try this level so that we can gather as much information as possible before a final decision is made in 2007.

Getting back on track, September brought us an extremely well attended single event hosted by Navesink River HRC, which included the Hunter Level. This was followed up by two double-staked tests at Hudson Highlands HRA and Northern Piedmont RC.

All in all, I believe NAHRA had an excellent year here in the Northeast. Yes, we still have some judging and administrative issues to improve upon but I feel we are back in the drivers seat and headed in the right direction.

While they are too many to name individually, I would like to express my thanks to all of the Northeast Club leaders who make this region run pretty well. Many thanks to the members of the Leatherstocking Hunting Retriever Association, Navesink River Hunting Retriever Club, Hudson Highlands Hunting Retriever Association and the Northern Piedmont Retriever Club for holding extra events to allow our members additional opportunities to run their dogs.

To all my friends across the country, I wish you safe and bountiful hunting seasons! Keep your powder dry and pick em up clean!

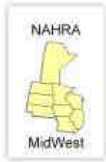




From The Regions

Dick Shelton was also a happy Okoboji tester with his pup's first ribbon.

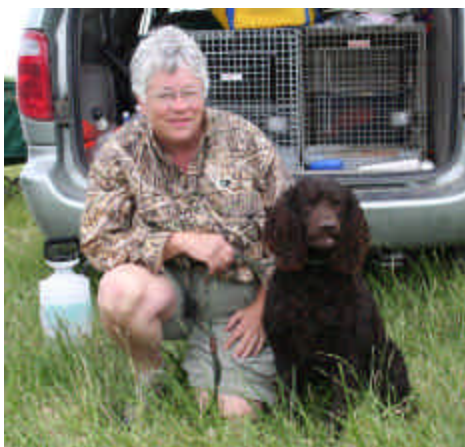

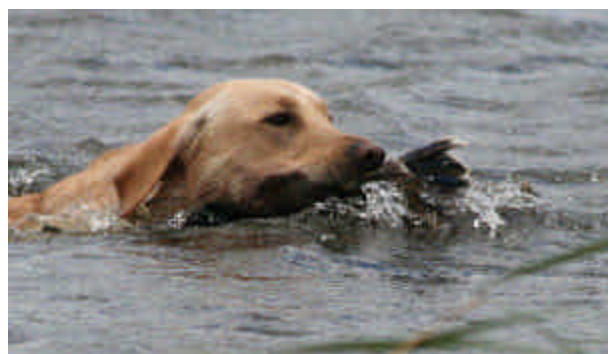

The Midwest RC of central Iowa reorganized last year and came back with a great test near Des Moines in July. The county-owned Chichaqua Bottoms Wildlife Area includes grounds that are groomed for field trials with a fabulous marsh. My training partners Terry and Gabby finished MHR at that one!

Good turnout and a great weekend – except for Iowa's usual mid-summer heat and humidity. Some of you eNews readers might not know Iowa's two seasons: October and Disgusting. But Disgusting has Too parts: Too Hot and Too Cold... We're really enjoying October, getting ready for the 20 below stuff...

Four Points RC, our most ambitious club, was back in August hosting the Regional. There were 137 entries, about as big as any NAHRA event I can remember in the last 22 years. This time the grounds were in central Minnesota near St. Cloud. A great place. We also held a meeting of the MidWest Region club contacts Friday night before the test. It gave us a chance to clear some things up that just didn't make it through email.

The long distance travelers at that test were a contingent of Pennsylvanians lead by Frank and Valerie Plewa. They traveled almost as far as from Central Flyway to Skunk River HRA. It's really nice to meet NAHRA folks from other Regions and very helpful to the program to exchange judges. Valerie judged Intermediate on Saturday and Hunter Sunday.

The tests were great, but the shooting was truly outstanding. I think they expended a box of live rounds for each dog – it didn't stand out as good shooting, just LOTS... Since we did the judges' roundtable last Spring, we're thinking of hosting a shotgunning clinic next year... ;-)

Eastern Iowa HRA hosted the final test of the season in early September at Bubbaland. Our usual grounds were so dried up that we couldn't host an event. John Pease, who owns FC/AFC Hilltop's Hayseed, "Bubba", let us use his private Training grounds. WOW! What a place. It was a big event for September and went very well – except for the rain.
